Sri Ramachandra Faculty of Pharmacy , Sri Ramachandra Institute of Higher Education and Research (Deemed to be University), No.1 Ramachandra Nagar, Porur, Chennai - 600 116, Tamil Nadu should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
